Standard terms Art The Hague

Parties

- 1. ----, Short 'participant';
- 2. Artik Projects Ltd, hereinafter referred to as "organizer."

Agreement

- 1. The agreement between participant and organizer goes for the art fair Art The Hague.
- 2. Art The Hague is organized in Fokker Terminal in The Hague. The days of Wednesday, October 4 through Sunday, October 8, 2017.
- 3. The agreement applies to the following states: Exhibition participants Art The Hague: stand ----
- 4. The amount of participation is € ----,- excluding VAT.

Standard Terms Art The Hague

- 1. For points above a fixed fee of € ----,- excluding 21% VAT, which the participant within the separate invoice to send payment deadline will be met.
- 2. Other agreements relating to this agreement must be in writing.
- 3. Failure to obtain an event shall be considered to condition subsequent to the agreement. Even if it is decided by the organizer that Art The Hague can not proceed, this agreement is automatically terminated. An amount already paid will be returned to participant.
- 4. If the show of force majeure can not proceed, the agreement remains in force.
- 5. The agreed artwork for print and internet ads, etc. produced and made available by the participant. The costs are borne by the participant.
- 6. Participant is liable for all costs arising from defective and/or untimely delivery of materials prepared by participants.
- 7. Organizer can not be held responsible for damage to borrowed property of participant fairgrounds, such as theft, molestation, arson etc.
- 8. The goods of the participant and during the entire period of the fair, including up and dismantling days before his own risk. The organizer excludes any liability in respect of loss, theft or damage to property and persons in any form whatsoever. The participant shall indemnify the organizer against any liability for damage caused by the participant of rent of the state and their works will be incurred and for damages to third parties by the participant or his representatives is caused.
- 9. Participant must ensure an appropriate liability an art insurance.
- 10. The organization is responsible for monitoring the art fair.
- 11. Participant is entitled to their own utterances (mailings, press releases, correspondence) Art The Hague the logo. The deployment of the artistic logo merchandise is exclusive to organizer. Using the artistic logo for the production of merchandise is only allowed if it is then written between organizer and participant agreed.
- 12. If you opt out of participation within a month prior to the art fair (after 4 September 2017), we bring you an invoice 50% of the entry fee.
- 12. Changes and / or additions to this agreement shall be effective unless in writing between the organizer and participant agreed.
- 14. This agreement is governed by Dutch law. Any disputes arising from this agreement or under contracts for insurance will be submitted to the District Court of The Hague.
